TERMS & CONDITIONS FOR PROVIDING MEDICAL REPORTS

- 1. Mr Chye Yew Ng MBChB(Hons), FRCS(Tr&Orth), DipSportsMed, DipHandSurg(Br&Eur) is a Consultant Hand & Peripheral Nerve Surgeon with expertise in the following subjects:
 - Adult brachial plexus injuries
 - Peripheral nerve injuries of upper and lower limbs
 - Scapular winging
 - Hand and wrist injuries
- 2. Mr Ng prepares medical reports for <u>Personal Injury</u> cases only.
- 3. It is the responsibility of the instructing party to arrange provision of all relevant medical records and imaging prior to Mr Ng seeing their client.
- 4. Mr Ng undertakes to provide an objective Expert Report addressed to the Court within 3 weeks of examining the client (providing all relevant medical records and imaging are available).
- 5. The medical records and CDs are returned to the instructing party upon completion of the report, unless otherwise specified.

Fees
